Food and Drugs Act

Regulations Amending Certain Regulations Made under the Food and Drugs Act  
This regulatory amendment proposes to amend the *Food and Drug Regulations* and the *Natural Health Products Regulations* to exempt drugs not listed on Schedule F to the *Food and Drug Regulations* from the preventative and treatment prohibitions in subsections 3(1) and 3(2) of the *Food and Drugs Act*. Drugs not listed on Schedule F include non-prescription drugs under the *Food and Drug Regulations* and natural health products (NHPs) under the *Natural Health Products Regulations*.

Pest Control Products Act

Pest Control Products Regulations  
The new PCPA modernizes and strengthens pest control product legislation and makes the registration system more transparent. In order to ensure that the objectives of the new Act are met, the existing PCPR must be revised. The revisions being proposed to the existing PCPR aim at implementing the new PCPA while minimizing the economic impacts or burden on businesses. The proposed revised PCPR will be structured in a very similar manner to the existing PCPR, although the language will be simplified, where possible, using plain language. The revised PCPR will continue to include provisions describing definitions of terms used in the Regulations, types of pest control products that are exempt from the Act or from registration, procedures detailing the registration process, including provisions relating to labelling requirements for products, packaging, storage and display, distribution, import, sampling and detention.

Regulations Amending the On-Road Vehicle and Engine Emission Regulations

The proposed amendments continue the approach of aligning with the federal emission standards of the EPA.

The combustion of fuels to power vehicles and engines contributes significantly to air pollution, which has major adverse impacts on the environment and on the health of Canadians. The proposed amendments will ensure that Canadian emission standards for on-road motorcycles remain aligned with more stringent standards adopted by the EPA. Accordingly, the proposed amendments would contribute to further reducing emissions of hydrocarbons (HCs), oxides of nitrogen (NO<sub>x</sub>) and certain air pollutants that have been listed as "toxic substances" in Schedule 1 to CEPA 1999 (e.g. benzene, 1,3-butadiene, formaldehyde, acetaldehyde and acrolein), and will thereby contribute to the protection of the environment and health of Canadians.

It is the intention of Health Canada to recommend that the *Food and Drug Regulations* be amended to permit the use of the genetically modified *Aspergillus oryzae* BECh2#3 (pCaHj559) as a production organism for the enzyme lipase used in bread, flour, unstandardized bakery products, modified egg yolk/whole egg, and the manufacture of hydrolysed lecithin at levels consistent with good manufacturing practice.

Regulations Amending the Food and Drug Regulations (1334 — Acetamiprid) Under authority of the *Pest Control Products Act*, the Pest Management Regulatory Agency (PMRA) of Health Canada has approved an application for the registration of the pest control product (pesticide) acetamiprid as an insecticide for the control of numerous insect pests on a variety of crops. This proposed regulatory amendment would establish Maximum Residue Limits (MRLs) under the *Food and Drugs Act* for residues of acetamiprid resulting from its use in Canada and other countries in amaranth, apples, arugula, bok choy Chinese cabbage, broccoli, broccoli raab, Brussels sprouts, cabbage, cardoon, cauliflower, celery, celtuce, Chinese broccoli, Chinese celery, Chinese mustard cabbage, citrus fruits, collards, corn salad, crabapples, dandelion leaves, dock, dried citrus fruit pulp, edible leaved chrysanthemum, eggplants, endives, fresh chervil leaves, fresh Florence fennel leaves and stalks, garden cress, garden purslane, garland chrysanthemum, grapes, groundcherries, head lettuce, loquats, kale, kohlrabi, leaf lettuce, mayhaws, mustard greens, mustard seed, mustard spinach, Napa Chinese cabbage, New Zealand spinach, orach leaves, oriental pears, parsley leaves, pears, pepinos, peppers, potatoes, quinces, radicchio, rape greens, rapeseed (canola), rhubarb, spinach, Swiss chard, tomatillos, tomatoes, tomato paste, undelinted cotton seed, upland cress, vine spinach and winter purslane, in order to permit the sale of food containing these residues. This proposed amendment would also establish MRLs for acetamiprid and its metabolite in eggs, in fat, liver and meat of poultry, in fat, meat and meat by-products of cattle, goats, hogs, horses and sheep, and in milk to cover residues in food derived from animals fed with crops treated with acetamiprid.

The Department of Transport (the Department) is proposing to amend the *Motor Vehicle Safety Regulations*. The proposed amendments are intended to

- introduce requirements, in Canada Motor Vehicle Safety Standard (CMVSS) 210.1, *User-ready Tether Anchorages for Restraint Systems* and in CMVSS 210.2, *Lower Universal Anchorage System for Restraint Systems and Booster Cushions*, for every bench seat on school buses to be equipped with either one or two sets, depending on the size of the bench seat, of user-ready tether and lower universal anchorages for the safe installation of child restraints; and
- add requirements, in CMVSS 210.1, for the installation of two sets of user-ready tether anchorages in buses, other than school buses, with a gross vehicle weight rating (GVWR) of 4 536 kg or less and specify, in CMVSS 210.2, the number of lower universal anchorages to be installed in those vehicles.

Chromium Electroplating, Chromium Anodizing and Reverse Etching Regulations *Canadian Environmental Protection Act, 1999* The proposed Regulations apply to any person or persons (user or users) using more than 10 kilograms of chromium trioxide (CrO<sub>3</sub>) per year. The users will be required to control the releases of HVC within the limits detailed below. To facilitate monitoring and enforcement of the proposed Regulations, users must retain all records, reports, plans, analytical methods, results from sampling, analysis, and other information for five years.
