# THIRTEENTH ANNUAL REVIEW OF THE IMPLEMENTATION AND OPERATION OF THE TBT AGREEMENT

Note by the Secretariat<sup>1</sup>

1. The Committee on Technical Barriers to Trade<sup>2</sup> (the Committee) will conduct its Thirteenth Annual Review of the Implementation and Operation of the TBT Agreement under Article 15.3 at its next meeting on 20 March 2008. This document contains information on developments in the Committee relating to the implementation and operation of the TBT Agreement from 1 January to 31 December 2007.

#### I. MEETINGS OF THE COMMITTEE

2. The Committee, pursuant to Article 13.1 of the TBT Agreement and to the Rules of Procedure, elected Mr. Raiminder SIDHU (India) as its Chairperson for the year 2007-2008.

3. Three meetings were held in 2007 (21 March, 5 July and 9 November 2007).<sup>3</sup> At these meetings, the Committee's attention was drawn to new or revised statements on implementation and administration of the Agreement, submitted under Article 15.2. In 2007, six Members submitted new statements under Article 15.2, while five issued revisions to existing statements.<sup>4</sup>

4. Forty-five specific trade concerns, twenty-eight of which were new concerns, were brought to the attention of the Committee with regard to the potential adverse trade effects of the measures, or inconsistency with the Agreement.<sup>5</sup>

5. During the review period, the Committee initiated an exchange of experiences on issues under Future Work items agreed at the Fourth Triennial Review of the Operation and Implementation of the Agreement under Article 15.4 (G/TBT/19), namely: (i) good regulatory practice; (ii) conformity assessment procedures; (iii) transparency; (iv) technical assistance; and, (v) special and differential treatment.

6. With a view to deepening understanding of the contribution good regulatory practice can make to the implementation of the TBT Agreement and advancing its work in this area, the Committee agreed to hold a workshop on good regulatory practice on 18-19 March 2008.<sup>6</sup> On transparency, the Committee agreed, at its 9 November 2007 meeting, on a new facility to attach texts of draft regulations to TBT notifications and on a new voluntary mechanism aimed at sharing unofficial translations of such texts.<sup>7</sup> On technical assistance, the TBT Committee discussed the functioning of the Format for the Voluntary Notification of Specific Technical Assistance Needs and Responses (G/TBT/16) and initiated an exchange of experiences regarding the delivery and receipt of technical assistance.

7. The Committee held its Fifth Special Meeting on Procedures for Information Exchange on 7-8 November 2007.<sup>8</sup> This special meeting addressed issues relating to: publication practices; notification practices; use of electronic tools; and technical cooperation and the work of Enquiry Points.

8. At its 21 March meeting, the Committee carried out its Twelfth Annual Review of the Implementation and Operation of the Agreement under Article 15.3 as well as the Twelfth Annual Review of the Code of Good Practice for the Preparation, Adoption and Application of Standards (Annex 3 of the Agreement).<sup>9</sup>

9. At its 9 November meeting, the Committee carried out the Sixth Annual Transitional Review mandated in Paragraph 18 of the Protocol of Accession of the People's Republic of China.<sup>10</sup>

10. During the regular meetings of the TBT Committee held in 2007, representatives of the Codex, IEC, ISO, ITC, OECD, OIML and UNIDO updated the Committee on activities relevant to its work, including on technical assistance.

11. During the review period, one notification of specific technical assistance needs and responses was made pursuant to the Committee's decision contained in G/TBT/16.<sup>11</sup>

#### II. TRANSPARENCY PROCEDURES<sup>12</sup>

#### *(i) Notifications of technical regulations and conformity assessment procedures*

12. In 2007, Members submitted 1,030 new notifications of technical regulations and conformity assessment procedures.<sup>13</sup> Since the entry into force of the Agreement on 1 January 1995, up to 31 December 2007, 8,774 such notifications have been made by 103 Members.





Figure 1: Total Number of TBT Notifications since 1995







13. Amongst the 1,030 notifications received in 2007, the following objectives have been mentioned by Members<sup>15</sup>: protection of human health or safety (in 678 notifications); prevention of deceptive practices (in 184 notifications); protection of the environment (in 173 notifications); consumer information and labelling (in 75 notifications); quality requirements (in 74 notifications); adoption of new domestic law (in 68 notifications); harmonization (in 28 notifications); protection of animal or plant life or health (in 29 notifications); lowering or removal of trade barriers and trade facilitation (in 8 notifications); national security requirements (in 2 notifications); and cost saving and increasing productivity (in 4 notifications). 263 notifications referred to more than one objective, 32 notifications referred to other objectives, and two did not specify any legitimate objective.

14. In 1995, the Committee recommended that the normal time-limit for presentation of comments on notified technical regulations and conformity assessment procedures should be 60 days. Moreover, it was recommended that any Member able to provide a time limit beyond 60 days, such as 90 days, was encouraged to do so.<sup>17</sup> In 2007, Members allowed an average of 59.9 days for comments. 148 notifications either did not specify a comment period, or stated it as non applicable or had a comment period which had lapsed. Figure 4 shows the average time allowed for comments since 1995.

#### *(ii)* Notifications under Article 10.7

15. In 2007, three notifications were made under Article 10.7 regarding agreements on issues related to technical regulations, standards or conformity assessment procedures. These notifications pertained to: (i) a mutual recognition arrangement on conformity assessment between the Bureau of Standards, Metrology and Inspection (BSMI) of the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu (TPKM) and the Standards, Productivity and Innovation Board (Spring) of Singapore (G/TBT/10.7/N/51), notified by Chinese Taipei; (ii) an agreement among the Association of South East Asian Nations (ASEAN) notified by Singapore (G/TBT/10.7/N/52); and, (iii) an arrangement between the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu (TPKM) and New Zealand on the Mutual Recognition of Test Reports and Certificates of Conformity for Electrical and Electronic Equipment, notified by Chinese Taipei (G/TBT/10.7/N/53).

#### *(iii)* Notifications under the Code of Good Practice

16. In 2007, one new notification of acceptance of the Code of Good Practice was submitted by the standardizing body of Brunei Darussalam.<sup>18</sup> Since the entry into force of the Agreement and up until 31 December 2007, 160 standardizing bodies from 116 Members have adhered to the Code.<sup>19</sup> Document G/TBT/CS/2/Rev.14 contains the list, by Member, of standardizing bodies that have accepted the Code since 1 January 1995 up until 31 January 2008. The ISO/IEC Information Centre has prepared the Thirteenth Edition of the WTO TBT Standards Code Directory which lists all standardizing bodies that have notified their acceptance of the Code together with the addresses of these standardizing bodies and information related to the availability of their work programmes.

#### *(iv) Means of access to additional information relevant to transparency*

- 17. The following is a list of sources where relevant information can be found:
  - (a) Information on publications used to announce that work is proceeding on draft technical regulations and conformity assessment procedures under Articles 2.9.1 and 5.6.1 of the Agreement, and publications in which the final texts are published under Articles 2.11 and 5.8 is contained in document G/TBT/2 and addenda. A list of official publications in relation to technical regulations, conformity assessment procedures and standards is contained in document G/TBT/GEN/39/Rev.1 (List of Members' Publications in Relation to Technical Regulations, Conformity Assessment Procedures and Standards).
  - (b) The list of WTO TBT Enquiry Points under Articles 10.1 and 10.3 is contained in document G/TBT/ENQ/31. The addresses of Enquiry Points are also available on the TBT Website.<sup>20</sup>
  - (c) In addition to the usual means of distribution, TBT notifications are also circulated through an automatic mailing list, once a week in the original language.<sup>21</sup>

#### III. TECHNICAL ASSISTANCE AND SPECIAL AND DIFFERENTIAL TREATMENT<sup>22</sup>

- 18. In 2007, the Secretariat organized three regional workshops in:
  - (a) Bahrain for Arab and Middle East countries;<sup>23</sup>
  - (b) Botswana, for English-speaking African countries;<sup>24</sup> and
  - (c) Malaysia, for Asia-Pacific economies.<sup>25</sup>

19. The programmes of these workshops were designed to assist participating economies from the different Regions to consolidate knowledge of the principles and disciplines of the TBT Agreement. The workshops also introduced participants to work and discussions in the TBT Committee, with a view to promoting a more effective participation of the various regions in the Committee's work. In particular, issues arising from the Future Work agreed at the Fourth Triennial Review of the TBT Agreement were explained and discussed in detail. The workshops also provided a forum for participants to share experiences with respect to technical barriers to trade and implementation of the Agreement. Several observer organizations in the TBT Committee, such as Codex, the International Electrotechnical Commission (IEC), the International Organization for Standardization (ISO), International Organization for Legal Metrology (OIML), and the United Nations Industrial Development Organization (UNIDO) participated the workshops.<sup>26</sup> In addition, experts from Members were invited to share experiences with respect to the implementation of the Agreement and the work of the Committee.<sup>27</sup> Co-operation was also received from regional partners: for instance, SADC provided inputs to the workshop for English-speaking African countries held in Botswana.

20. At the Third Triennial Review of the TBT Agreement (November 2003), it was recommended that, in order to fulfil the obligation contained in Article 15.2 of the TBT Agreement, Members should seek assistance from other Members that had done so to share their knowledge and experience in this regard. At the Fourth Triennial Review, the Committee reiterated the importance of Members fulfilling their obligation under Article 15.2. During 2007 regional and national technical assistance activities, particular attention was given to the process of preparing and submitting statements on implementation and administration of the TBT Agreement under Article 15.2. The Secretariat also

organized a workshop in Geneva on this topic in November 2007.<sup>28</sup> The workshop offered Members an opportunity to present and discuss different approaches utilized in the development of their 15.2 statements.

21. In response to requests received from individual Members, seven national workshops were organized in: Niger, Paraguay, Gabon, El Salvador, Nicaragua, Nigeria and Malaysia. These workshops aimed at promoting a better understanding of the rights and obligations under the TBT Agreement and at addressing issues of specific interest to these Members, including good regulatory practice and their specific trade concerns.

22. For the first time, technical assistance activities in the year under review included four etraining courses on the TBT Agreement held in the three official languages of the WTO. These online courses were addressed to government officials from developing country Members and Observers and covered all aspects of the TBT Agreement.<sup>29</sup>

23. The trade policy courses organized by the WTO Secretariat, both Geneva-based and regional, included sessions on the TBT Agreement. TBT training was provided in the regional trade policy courses held in Singapore for the Asian region, in Namibia for English-speaking African countries, and in Chile for Latin America. Other technical assistance activities included the Geneva-based Fifth Special Meeting on Procedures for Information Exchange (see paragraph 6, above).<sup>30</sup>

#### IV. DISPUTES INVOLVING PROVISIONS OF THE TBT AGREEMENT

24. The state of play during the year 2007 with regard to disputes that have involved provisions of the TBT Agreement is summarized below.
