IMPLEMENTATION AND ADMINISTRATION OF THE AGREEMENT ON TECHNICAL BARRIERS TO TRADE

COMMUNICATION FROM KAZAKHSTAN

Addendum

The following communication under Article 15.2 of the Agreement on Technical Barriers to Trade has been received from <u>Kazakhstan</u>.

1 INTRODUCTION

1.1. In accordance with Article 15.2 of the Agreement on Technical Barriers to Trade (TBT Agreement) and the Decision taken by the Committee on Technical Barriers to Trade (G/TBT/1/Rev.12), We would like to submit to the Committee the summarized information on the measures, in existence and taken, to ensure the implementation and administration of the TBT Agreement in the Republic of Kazakhstan.

2 RELEVANT LAWS AND REGULATIONS

2.1. The legal framework of the Republic of Kazakhstan for technical regulations, standards and conformity assessment systems is governed by the Eurasian Economic Union (EAEU) Treaty, international agreements of the Customs Union (CU)1 and by other EAEU, CU Acts, and the national legislation of Republic of Kazakhstan to these agreements. As of 1 January 2015, the CU legal instruments were incorporated into the EAEU legal framework, including technical regulations of the CU which became technical regulations of the EAEU. EAEU Acts and domestic legislation in respect of standards, technical regulations, and conformity assessment in the Republic of Kazakhstan are listed in Annex I to this notification.

2.2. Thirty-four technical regulations of the Eurasian Economic Union that are currently applied in the territory of the Eurasian Economic Union are listed in Annex II.

2.3. One technical regulation of the Eurasian Economic Union adopted by the Decision of the Council of the Eurasian Economic Commission No. 107 of 12 November 2014 on tobacco products enters into force 15 May 2016.

2.4. Sixty nine national technical regulations that are currently applied in the Republic of Kazakhstan are listed in Annex III to this document.

3 TRANSPARENCY

3.1 Publications

3.1. The republican level newspaper, the official publication of the authorized body "Technical Regulation Bulletin", "Gosstandard News", "Monthly Informational Index of Standards" and

"Bulletin of the Enquiry Point on TBT and SPS" journals are the publications where notices on draft technical regulations and procedures for assessment of conformity are announced. The texts of newly approved regulations or procedures for conformity assessment are also published there. The same notices are also placed on the website of the Eurasian Economic Commission at http://www.eurasiancommission.org/, the Committee for Technical Regulation and Metrology at http://www.memst.kz/ and the National Enquiry Point on TBT and SPS at https://wto.memst.kz/.

3.2. The programme of development of national standards and every draft standard of the Republic of Kazakhstan with notice on the beginning of a public discussion period are published on the website of the Committee for Technical Regulation and Metrology at https://www.memst.kz/ and official publication "Code of Normative Acts of the President of the Republic of Kazakhstan and Government of Kazakhstan", "Technical Regulation Bulletin".

3.2 Time for comments

3.3. The expected time limits for the submission of comments in writing on draft technical regulations, standards or conformity assessment procedures is 60 days, with exceptions made in certain cases (depending on urgency consideration) where this period could be extended or reduced.

3.3 Enquiry point

3.4. As it is foreseen in Articles 10.1 and 10.3 of the TBT Agreement, the National Enquiry Point has been established in the Republic of Kazakhstan.

3.5. Department for Foreign Trade Activity Development of the Ministry of National Economy of the Republic of Kazakhstan is the National Enquiry Point for the Republic of Kazakhstan. The contact address is:

3.4 National authorities and agencies

3.6. The Committee for Technical Regulation and Metrology of the Ministry of Investment and Development (Kazmemst) is the central body of executive power in the area of technical regulation, standardization and conformity assessment. The Committee implements the policy of the Republic of Kazakhstan in these areas.

3.5 Measures for new technical regulations or conformity assessment procedures

3.7. Article 10 and Article 19 of the Law "on technical regulation" No. 603 of 9 November 2004 specify the procedures enabling the relevant national authority to fulfill its obligations under Articles 2.9, 2.10, 3.2, 5.6, 5.7 of the Agreement on Technical Barriers to Trade that is the obligation to notify preparation of new technical regulations or procedures for assessment of conformity or substantial amendments to existing ones.
