The draft ordinance repeals the ordinance no. 12, dated 15 July 2014 "On determining the safety and quality indicators of wheat pre-packed, to be sold to the ultimate consumer or for the manufacture of other food products".

The regulation is intended to be the legal basis to conduct importation, with the aim to: protect public health, animal health and environmental health; ensure fulfilment of the requirements linked to safety and health-related concerns, as well as legal obligations; ensure imported carcasses, meat and/or its processed products are free from zoonoses and animal infectious diseases, chemical and physical hazards; provide certainty in importation of carcasses, meat and/or its processed products. The scope of this regulation includes: a. Import Procedures; c. Control; d. Veterinary import requirements for poultry meat, meat and its processed products; e. Types of meat from cattle, carcass and/or meat other than cattle, and processed meat products that can be imported into the territory of the Republic of Indonesia; f. Other provisions.

The intended use of beef for hotels, restaurants, catering, industrial and other special purposes imported by the State-Owned Enterprises are to stabilize prices through market operations and disaster support (Article 32, paragraph 4). 3. Business communities, the State-Owned Enterprises, Regional Enterprises, Social Institutions, and Foreign State Representative/International Institutions which import carcasses, meat and/or its processed products shall report the realization of prior period importation when applying for a new recommendation in accordance with the Format-4 (Article 33, point d). Other provisions stipulated in the Regulation of the Minister of Agriculture No. 139/Pementan/PD.410/12/2014 concerning Importation of Carcasses. Meat and/or Its Processed Products

Importation of Carcasses, Meat and/or Its Processed Products Into the Territory of the Republic of Indonesia still remain valid.
