Quarantine pests and diseases of Fish which can be free from its carrier because the treatment's technologies have been mastered; d. Carrier of QPDF means fish and/or other material capable of carrying Quarantine Pests and Diseases of Fish and/or Certain Fish Pest and Diseases; e. Fish means all aquatic biota the life cycle of which takes place whole or partly in water, whether alive or dead, including parts thereof.
