Bovine meat (beef) as listed in Annex I consisting of prime cut, manufacturing meat, and variety/fancy meat; b. Carcass, small ruminant meat, pork and its products as listed in Annex II; c. Bovine meat (beef) as listed in Annex III consisting of carcass and secondary cut; Importation of bovine meat as listed in Annex III, only for national or local state-owned enterprises; Importation of beef requires consideration of the local beef absorption rate. The amount of absorption of local beef is as follows: a. For general importers - 3% of the total amount of the next consignment of imports; b. For importers/producers - 1.5% of the total amount of the

				next consignment of imports; The shelf-life of carcasses and meat on arrival into the territory of Indonesia should be as follows: a. For frozen products - no longer than six months; b. For fresh chilled products - no longer than three months from the slaughtering or processing time until arrival into the territory of Indonesia; Import procedures and the submission of recommendations: c. Applications for recommendations are submitted three times a year: between 1 to 31 December; between 1 to 31 August of the current year; d. The approval/rejection of applications for recommendations takes a maximum of four working days after submission of the completed application along with the stipulated administrative requirements. Applications are submitted online to the Director General of Livestock and Animal Health Services through PPVTPP; e. The recommendation is signed by the Director General of Livestock and Animal Health Services; f. The recommendation is issued three times a year, i.e. December of the previous year, April and August; g. Validity period of technical recommendation corresponds to three periods in a year, namely: The first validity period: from 1 January - 30 April; The second validity period: from 1 May - 31 August; The third validity period: from 1 September - 31 December; h. The Ministry of Public Health (MOPH) considered that it was appropriate to revise the detail of food additives labelling as follows: • Clause 1 - Revised some of the existing provisions of food additives labelling in order to comply with the Notification of the Ministry of Public Health, No. 367 B.E. 2557 (2014) entitled Labelling of Prepackaged Foods, dated 8 May B.E. 2557 (2014). These revisions include: - name and address of manufacturer or packers or importers or head office; - month and year of manufacture and expiration; - details of food additives manufactured for export. • Clause 2 - Amended the requirements by adding specific conditions for labelling of food additives derived from combining two or more kinds of food additives which are to be sold to food manufacturers or used as raw materials in food processing, but not sold directly to consumers or sold to food additive packers. However, there are two cases which may not require the declaration of the percentage of food additives on the label or in the manual or in the documents relating to the sale. These cases are indicated below: 1. The manufacture or imports of food additives for use in their own food product (or the same trademark of such manufacture or imports); or 2. The manufacture or imports of food additives for sale to food manufacturers with agreement to provide information of percentage of food additives. This MOPH Notification will be enforced after it is notified in the Official Gazette.

The MOPH Notification No. 296 (B.E. 2549) (2006) entitled "Re: Foods with Risk from Bovine Spongiform Encephalopathy", dated 13 January 2006, is repealed and replaced by this (Draft) MOPH Notification; 2. Classified the BSE risk status of the bovine population of a country, zone or compartment into three categories according to the OIE criteria, as follows: - Category 1: Negligible BSE risk Country; - Category 2: Controlled BSE risk Country; 3. Described the definitions of "Beef", "Fresh Beef" and "Beef products"; 4. Prescribed the import requirements for fresh beef and beef products for human consumption into Thailand according to the OIE criteria; 5. The following organs: tonsils, distal ileum, brains, eyes, spinal

It is composed of six chapters, 33 sections. 1. In this Act, it controls the marketing of Infant and young child food and related products that includes: "Infant" means a child from birth under the age of 12 months. - "Young child" means a child aged between 12 months to three years. "Food for infant and young child" means infant formula, follow-up formula for infant and young children, and continuous milk for young children , complementary food that are marketed as products for infants and young children, and including other kinds of food for infant and young children, and including other kinds of food for infant and young children, with the advice of the Committee. - "Related products" means milk containers, milk bottles, teats, or other products proclaimed by the Ministerial Notice with the advice of the Infant and Young Child Food and Related Products Marketing Committee. 2. The Committee on the Control of Marketing of Infant and Young Child Food and Related Products shall be established and composed of the government, academic, and NGOs representatives. 3. In regards to infant formula, follow-on formula, and continuous milk for young children; manufacturers, importers, and distributors are not allowed, with some exceptions, to engage in following activities: (1) advertising; (2) Sales promotion; (3) Offering product samples; (4) Donation; (5) Offering of object that carries the name, logo, signs, or symbols that may be related to the products to pregnant women, mothers or family members of infant and young children, whether directly or indirectly; (6) Sponsoring event

Producers, importers, or distributors or its representative must provide factual product information to medical, nursing professional, and public health personnel and not provide information in following manner; falsely present, distort the details, overstate the benefit or properties, create misunderstanding of key information, claim or certify the benefits without scientific evidence, and make reference to breast-milk. 6. Object or communication materials with information on infant formula and follow-on formula must also indicate the approximate financial cost for feeding infant and young children with infant formula and follow-on formula and warning about health hazards caused by inappropriate preparation or use of the product. 7. Medical and nursing professionals and public health personnel shall be obliged to provide counselling and education about the implementation of this Act and notify the Department of Health or the officials when the violation of this Act is observed. 8. Any person who contravenes this Act will be liable for a fine. Medical and nursing professionals and public health personnel who engaged with the misconduct of this Act will be reported to the professional organization to consider appropriate measure according to the professional organization.
