LTEC is seeking comment on a proposed revision of the fuel consumption labelling standard (ADR81/01). The Department of Transport and Regional Services(DOTARS) is managing this consultation process on behalf of LTEC.

Please find below a link to the final LTEC Position Paper and draft ADR81/02 regarding Fuel Consumption Labelling for Light Vehicles. The Position Paper recommends the introduction of a new ADR81/02 which adopts the latest ECE Regulation and proposes a revised fuel consumption label. The position paper takes into account feedback following a discussion paper circulated for public comment earlier this year.

INVITATION TO COMMENT ON UPDATE OF FUEL CONSUMPTION LABELLING (ADR81/01)

LTEC is seeking comment on a proposed revision of the fuel consumption labelling standard (ADR81/01). The Department of Transport and Regional Services is managing this consultation process on behalf of LTEC.

The proposed changes to the ADR reflect the inclusion of the latest ECE Regulation for determining fuel consumption and CO2 emission values. The review also includes options for a revised fuel consumption label to reflect the additional data provided under the regulation.

The proposed changes are explained in the LTEC Paper on Review of ADR81/01 Fuel Consumption Labelling for Light Vehicles. If adopted, the proposed changes would require ADR81/01 to be remade as ADR81/02.

Comments should be provided to the Department of Transport and Regional Services. Details on submitting comments are included in section 1.3 of the LTEC Paper. All comments must be provided in writing.
