CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Notice is hereby given that, pursuant to the provisions of Part 7, Division 3, of the *Canadian Environmental Protection Act, 1999*, Permit No. 4543-2-03384 is approved.

- 1. Permittee: Fraser River Pile & Dredge Ltd., New Westminster, British Columbia.
- 2. *Type of Permit*: To load waste and other matter for the purpose of disposal at sea and to dispose of waste and other matter at sea.
- 3. Term of Permit: Permit is valid from January 2, 2006, to January 1, 2007.
- 4. *Loading Site(s)*: CIPA Lumber Products, Delta, British Columbia, at approximately 49°10.62' N, 122°56.65' W.
- 5. *Disposal Site(s)*: Point Grey Disposal Site: 49°15.40' N, 123°22.10' W, at a depth of not less than 210 m.

The following position-fixing procedures must be followed to ensure disposal at the designated disposal site:

- (i) The vessel must inform the appropriate Marine Communications and Traffic Services (MCTS) Centre upon departure from the loading site that it is heading for a disposal site;
- (ii) Upon arrival at a disposal site and prior to disposal, the vessel must again call the appropriate MCTS Centre to confirm its position. Disposal can proceed if the vessel is on the designated site. If the vessel is not within the disposal site boundaries, the MCTS Centre will advise the bearing and distance to the site and advise when disposal can

proceed; and

- (iii) The vessel must inform the appropriate MCTS Centre when disposal has been completed prior to leaving the disposal site.
- 6. Route to Disposal Site(s): Direct.
- 7. *Method of Loading and Disposal*: Clamshell dredging with disposal by bottom dump scow or end dumping.
- 8. Rate of Disposal: As required by normal operations.
- 9. Total Quantity to Be Disposed of: Not to exceed 12 000 m³.
- 10. Waste and Other Matter to Be Disposed of: Dredged material consisting of silt, sand, rock, wood waste and other approved material typical to the approved loading site except logs and usable wood.
- 10.1. The Permittee must ensure that every reasonable effort has been made to prevent the deposition of log bundling strand into material approved for loading and ocean disposal and/or remove log bundling strand from material approved for loading and ocean disposal.
- 11. Requirements and Restrictions:
- 11.1. The Permittee must notify the permit-issuing office before commencement of the project as to the dates on which the loading or disposal will occur.
- 11.2. The Permittee must ensure that all contractors involved in the loading or disposal activity for which the permit is issued are made aware of any restrictions or conditions identified in the permit and of the possible consequences of any violation of these conditions. A copy of the permit and of the letter of transmittal must be carried on all towing vessels and loading platforms or equipment involved in disposal at sea activities.
- 11.3. The fee prescribed by the *Ocean Dumping Permit Fee Regulations (Site Monitoring)* shall be paid by the Permittee in accordance with those Regulations.
- 11.4. Contact must be made with the Canadian Coast Guard, Regional Marine Information Centre (RMIC), regarding the issuance of a "Notice to Shipping." The RMIC is located at 2380–555 West Hastings Street, Vancouver, British Columbia V6B 5G3, (604) 666-6012 (telephone), (604) 666-8453 (fax), rmic-pacific@ pac.dfo-mpo.gc.ca (email).
- 11.5. Any enforcement officer designated pursuant to subsection 217(1) of the *Canadian Environmental Protection Act*, 1999 shall be permitted to mount an electronic tracking device on any vessel that is engaged in the disposal at sea activities authorized by this permit. The Permittee shall take all reasonable measures to ensure that there is no tampering with the tracking device and no interference with its operation. The tracking device shall be removed only by an enforcement officer or by a person with the written consent of an enforcement officer.

11.6. The Permittee must submit to the Regional Director, Environmental Protection Branch, within 30 days of the expiry of the permit, a list of all work completed pursuant to the permit, the nature and quantity of material disposed of and the dates on which the activity occurred.

- (iii) The vessel must inform the appropriate MCTS Centre when disposal has been completed prior to leaving the disposal site.
- 6. Route to Disposal Site(s): Direct.
- 7. *Method of Loading and Disposal*: Loading by clamshell dredge or suction cutter dredge and pipeline, and disposal by hopper barge or end dumping.
- 8. Rate of Disposal: As required by normal operations.
- 9. Total Quantity to Be Disposed of: Not to exceed 7 000 m³.
- 10. *Material to Be Disposed of*: Dredged material consisting of silt, sand, rock, wood waste and other approved material typical to the approved loading site except logs and usable wood.
- 10.1. The Permittee must ensure that every reasonable effort has been made to prevent the deposition of log bundling strand into material approved for loading and ocean disposal and/or remove log bundling strand from material approved for loading and ocean disposal.
- 11. Requirements and Restrictions:
- 11.1. The Permittee must notify the permit-issuing office in writing and receive written approval for each loading site prior to any loading or disposal. The written notification must include the following information:
- (i) the coordinates of the proposed loading site;

- (ii) a site map showing the proposed loading site relative to known landmarks or streets;
- (iii) a figure showing the legal water lots impacted by the proposed dredging or loading activities, giving the spatial delineations of the proposed dredge site within these water lots;
- (iv) all analytical data available for the proposed loading site;
- (v) the nature and quantity of the material to be loaded and disposed of;
- (vi) the proposed dates on which the loading and disposal will take place; and
- (vii) the site history for the proposed loading site.

Additional requirements may be requested by the permit-issuing office.

- 11.2. The Permittee must ensure that all contractors involved in the loading or disposal activity for which the permit is issued are made aware of any restrictions or conditions identified in the permit and of the possible consequences of any violation of these conditions. A copy of the permit and of the letter of transmittal must be carried on all towing vessels and loading platforms or equipment involved in disposal at sea activities. A copy of the written approval for the appropriate loading site must be displayed with each copy of the permit posted at the loading sites.
- 11.3. The fee prescribed by the *Ocean Dumping Permit Fee Regulations (Site Monitoring)* shall be paid by the Permittee in accordance with those Regulations.
- 11.4. Contact must be made with the Canadian Coast Guard, Regional Marine Information Centre (RMIC), regarding the issuance of a "Notice to Shipping." CUSTOMS TARIFF

Invitation to submit comments on the proposed elimination of (a) tariffs on certain textile items where Canadian production of these textiles is limited; and (b) gender and product specificity in certain textile tariff item descriptions

The Government is seeking the views of interested parties on the proposed elimination of the tariffs on certain textile products where Canadian production of these products is limited. The Government is also seeking views on the proposed elimination of gender and product specificity currently found in certain textile tariff item descriptions.

Background

Proposed elimination of tariffs on textiles with limited production in Canada

In December 2004, the Government announced a number of measures designed to assist the Canadian textile and apparel industries. One of these measures involved the elimination of the tariffs on fibres, yarns and apparel fabrics, effective January 1, 2005. It was made clear at the time of the announcement that the tariff relief would be focused on products not made in Canada, in order to minimize any adverse effects on domestic textile producers.

To this end, the Canadian International Trade Tribunal (the Tribunal) was directed to inquire into and report on the availability of fibres, yarns and fabrics produced in Canada and to propose a tariff structure that reflected availability. The Tribunal issued its final report (*Report on the Production in Canada of Certain Fibres, Yarns and Apparel Fabrics*) on June 30, 2005, and recommended the elimination of the tariffs on a number of textile products. These recommendations were implemented on November 21, 2005.

The Tribunal Report also identified 35 tariff items where the domestic production of textiles was less than an average of \$5,000 over the two-year period 2003-2004 (see Table 1). Imports under these tariff items amounted to some \$120 million in 2004, and the duties paid were roughly \$5 million. The Tribunal Report also recommended the creation of 4 new tariff items (identified in Table 1 with an asterisk) where the domestic production of textiles related to each of these items would be less than \$5,000 annually.

Given the limited domestic production of these textiles, the Government announced, on October 28, 2005, that it would consult with industry on the elimination of the tariffs on these items. Therefore, producers are hereby invited to provide information on the significance of any negative impact that might result from the elimination of these tariffs.

Review of the continued need for gender/product specific textile tariff descriptions

The *Customs Tariff* contains certain textile tariff items that have differing tariff rates depending on whether they are used in the production of men's/boys' or women's/girls' apparel. The Government is proposing to replace these gender-specific tariff descriptions with gender-neutral descriptions and generic apparel, rather than product specific enduse conditions.

As the fabrics in question are generally not available from Canadian production, these gender-specific conditions do not appear to be necessary to protect the interests of domestic textile producers. On the other hand, a number of apparel producers have advised that the elimination of the gender-specific conditions in these provisions would help to reduce their manufacturing costs and improve their competitiveness in the marketplace. In view of this, the Government is seeking the views of producers and importers on the replacement of the gender and product specific tariff item descriptions listed in Table 2 with the proposed gender and product neutral descriptions. The rates of duty corresponding to the tariff item descriptions would not be affected.

Submissions

Submissions relating to either of the above proposals should contain full information on the relevant eight-digit tariff items, including, where appropriate,

- detailed descriptions of fabrics produced or imported under the tariff item:
- the total value of each of the fabrics produced for sale to domestic apparel producers or for use in the internal production of apparel since January 1, 2003;
 and
- the significance of this production to overall manufacturing operations, including detailed information to substantiate any expected adverse impact resulting from the proposed amendments.

Confidential information will be protected. In this regard, information considered "commercially confidential" should be clearly designated as such.

Notice No. SMSE-014-05 — Amendment of Radio Standards Specification 213 (RSS-213)

Notice is hereby given that Industry Canada is amending Radio Standards Specification 213 (RSS-213), which sets out minimum requirements for the certification of licence-exempt personal communications services (LE-PCS) in the lower 1 900 MHz frequency range.

The RSS was amended for the purpose of updating the Canadian requirements for LE-PCS in order to harmonize them with the latest international requirements, particularly those of the Federal Communications Commission (FCC) in the United States. Other changes consist of general reformatting of the document and contact information updates. This revised RSS is

Radio Standards Specification 213, Issue 2, 2 GHz Licence-exempt Personal Communications Service Devices (LE-PCS) [RSS-213].

The major changes made to RSS-213 are summarized below:

- (1) RSS-213, Issue 1, applied to the 1 910-1 920 MHz and 1 920-1 930 MHz bands. RSS-213, Issue 2, applies only to the 1 920-1 930 MHz band, as the 1 910-1 920 MHz band is no longer available for licence-exempt personal communications service operation.
- (2) RSS-213, Issue 1, permitted the operation of asynchronous devices only in the 1 910-1 920 MHz band and isochronous devices only in the 1 920-1 930 MHz band. RSS-213, Issue 2, permits both isochronous and asynchronous devices to operate in the band 1 920-1 930 MHz.
- (3) RSS-213, Issue 1, required non-nomadic LE-PCS devices to meet Location Verification Process (LVP) criteria to coordinate with existing fixed licensed microwave services in the band. Since it is not feasible to coordinate nomadic LE-PCS devices with existing services, certification of nomadic devices was not permitted until the coordination requirement for non-nomadic devices could be removed. The policy document (SAB-001-05), available electronically on the Spectrum Management and Telecommunications Web site at http://strategis. gc.ca/spectrum, establishes the removal of the coordination requirement for non-nomadic LE-PCS and, accordingly, the removal of the prohibition on the certification of nomadic LE-PCS, in the 1 920-1 930 MHz band. These policy changes are reflected in RSS-213, Issue 2, through the removal of the LVP requirement for non-nomadic LE-PCS and by permitting the certification of nomadic LE-PCS devices.
- (4) The document was reformatted to bring it into alignment with the recently published RSS-Gen, *General Requirements and Information for the Certification of Radiocommunication Equipment.*

General information

The above document will come into force as of the date of publication of this notice.

This document has been coordinated with the Radio Advisory Board of Canada (RABC).

The Radio Equipment Technical Standards Lists will be amended to reflect the above change.
