Interested persons may make representations with respect to the proposed Regulations within 75 days after the date of publication of this notice. **REGULATIONS AMENDING SCHEDULE D TO THE FOOD AND DRUGS ACT  
(BLOOD AND BLOOD DERIVATIVES)**

AMENDMENT

**1. The reference to**

**Blood and blood derivatives**

in Schedule D to the *Food and Drugs Act* ([see footnote 1](#)) is replaced by the following:

Blood and blood derivatives, except cord blood and peripheral blood that are a source of lymphohematopoietic cells for transplantation
