CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Notice is hereby given that, pursuant to the provisions of Part 7, Division 3, of the *Canadian Environmental Protection Act, 1999*, Permit No. 4543-2-03435 is approved.

- 1. Permittee: Steveston Harbour Authority, Richmond, British Columbia.
- 2. Type of Permit: To load waste and other matter for the purpose of disposal at sea and to dispose of waste and other matter at sea.
- 3. Term of Permit: Permit is valid from October 1, 2007, to September 30, 2008.
- 4. Loading Site(s): Cannery Channel, Steveston, British Columbia, at approximately 49°07.30' N, 123°10.50' W.
- 5. *Disposal Site(s)*: Sand Heads Disposal Site, 49°06.00' N, 123°19.50' W, at a depth of not less than 70 m.

The following position-fixing procedures must be followed to ensure disposal at the designated disposal site:

- (i) The vessel must inform the appropriate Marine Communications and Traffic Services (MCTS) Centre upon departure from the loading site that it is heading for a disposal site;
- (ii) Upon arrival at a disposal site and prior to disposal, the vessel must again call the appropriate MCTS Centre to confirm its position. Disposal may proceed if the vessel is on the designated site. If the vessel is not within the disposal site

- boundaries, the MCTS Centre will advise the bearing and distance to the site and when disposal may proceed; and
- (iii) The vessel must inform the appropriate MCTS Centre when disposal has been completed prior to leaving the disposal site.
- 6. Route to Disposal Site(s): Direct.
- 7. *Method of Loading and Disposal*: Loading by clamshell or cutter suction dredge with disposal by bottom dump scow or by end dumping.
- 8. Rate of Disposal: As required by normal operations.
- 9. Total Quantity to Be Disposed of: Not to exceed 80 000 m<sup>3</sup>.
- 10. Waste and Other Matter to Be Disposed of: Dredged matter consisting of sand, silt, clay and other approved matter typical to the approved loading site.
- 11. Requirements and Restrictions:
- 11.1. The Permittee must notify the permit-issuing office in writing and receive written approval for each specific loading site located within the Cannery Channel prior to any loading and/or disposal at sea.
- 11.2. The Permittee must ensure that all contractors involved in the loading or disposal activity for which the permit is issued are made aware of the requirements and restrictions, as well as of the conditions identified in the permit and of the possible consequences of any violation of these conditions. A copy of the permit and of the letter of transmittal must be carried on all towing vessels and loading platforms or equipment involved in disposal at sea activities. A copy of the written approval for the appropriate loading site must be displayed with each copy of the permit posted at the excavation and loading sites.
- 11.3. Contact must be made with the Canadian Coast Guard, Regional Marine Information Centre (RMIC), regarding the issuance of a "Notice to Shipping." The RMIC is located at 2380–555 West Hastings Street, Vancouver, British Columbia V6B 5G3, 604-666-6012 (telephone), 604-666-8453 (fax), rmic-pacific@pac.dfo-mpo.gc.ca (email).
- 11.4. Any enforcement officer designated pursuant to subsection 217(1) of the *Canadian Environmental Protection Act*, 1999 shall be permitted to mount an electronic tracking device on any vessel that is engaged in the disposal at sea activities authorized by this permit. The Permittee shall take all reasonable measures to ensure that there is no tampering with the tracking device and no interference with its operation. The tracking device shall be removed only by an enforcement officer or by a person with an enforcement officer.
- 11.5. The Permittee must report to the Regional Director, Environmental Protection Operations Directorate, Pacific and Yukon Region, within 10 days of the completion of each loading site, the nature and quantity of material disposed of pursuant to the permit,

the disposal site and the dates on which the activity occurred.

11.6. The Permittee must submit to the Regional Director, Environmental Protection Operations Directorate, Pacific and Yukon Region, within 30 days of the expiry of the permit, a list of all activities completed pursuant to the permit, including the nature and quantity of matter disposed of from the loading site, the disposal site and the dates on which the activities occurred.

- 1. Permittee: G.A.P. Contracting Ltd., North Vancouver, British Columbia.
- 2. *Type of Permit*: To load inert, inorganic geological material for disposal at sea and to dispose of inert, inorganic geological matter at sea.
- 3. Term of Permit: Permit is valid from October 1, 2007, to September 30, 2008.
- 4. *Loading Site(s)*: Various approved sites in Greater Vancouver, at approximately 49°16.35' N, 123°06.70' W.
- 5. *Disposal Site(s)*: Point Grey Disposal Site, 49°15.40' N, 123°22.10' W, at a depth of not less than 210 m.

The following position-fixing procedures must be followed to ensure disposal at the designated disposal site:

- (i) The vessel must inform the appropriate Marine Communications and Traffic Services (MCTS) Centre upon departure from the loading site that it is heading for a disposal site;
- (ii) Upon arrival at a disposal site and prior to disposal, the vessel must again call the appropriate MCTS Centre to confirm its position. Disposal may proceed if the vessel is on the designated site. If the vessel is not within the disposal site boundaries, the MCTS Centre will advise the bearing and distance to the site and when disposal may proceed; and
- (iii) The vessel must inform the appropriate MCTS Centre when disposal has been

completed prior to leaving the disposal site.

- 6. Route to Disposal Site(s): Direct.
- 7. *Method of Loading and Disposal*: Loading by conveyor belts or trucks and disposal by bottom dump scow or end dumping.
- 8. Rate of Disposal: As required by normal operations.
- 9. Total Quantity to Be Disposed of: Not to exceed 50 000 m<sup>3</sup>.
- 10. Waste and Other Matter to Be Disposed of: Excavated matter comprised of clay, silt, sand, gravel, rock and/or other approved matter typical to the loading site. All wood, topsoil, asphalt and other debris are to be segregated for disposal by methods other than disposal at sea.
- 11. Requirements and Restrictions:
- 11.1. The Permittee must notify the permit-issuing office in writing and receive written approval for each loading site prior to any loading and/or disposal at sea. The written notification must include the following information:
  - (i) the coordinates of the proposed loading site;
  - (ii) a site map showing the proposed loading site relative to known landmarks and/or streets;
  - (iii) a figure showing the legal lots affected by the proposed excavation or loading activities, giving the spatial delineations of the proposed site within these lots;
  - (iv) all analytical data available for the proposed loading site;
  - (v) the nature and quantity of the material to be loaded and disposed of;
  - (vi) the proposed dates on which the loading and disposal will take place; and
  - (vii) the site history for the proposed loading site.

Additional requirements may be requested by the permit-issuing office.

11.2. The Permittee must ensure that all contractors involved in the loading or disposal activity for which the permit is issued are made aware of the requirements and restrictions, as well as of the conditions identified in the permit and of the possible consequences of any violation of these conditions. Notice No. SMSE-008-07 — Telecommunications and Radio Apparatus Fee Order

Introduction

Established in 1993, the *Telecommunications Apparatus Assessment and Testing Fees Order* (ATF) sets fees for the assessment, certification and testing services for radio and telecommunications apparatus. These services are necessary to ensure that such apparatus being sold or offered for sale in Canada meet all applicable regulatory requirements.

Over the past decade, there have been significant changes in both the technologies and business operations of the radiocommunication and telecommunications industries. Also, Canada has entered into several international mutual recognition agreements dealing with the recognition of foreign, private conformity assessment bodies that perform duties similar to those performed by Industry Canada.

The ATF has been revoked and replaced by the *Telecommunications and Radio Apparatus Fee Order* (TRAF) in order to deal with this emerging environment. This proposed structure was presented to the Terminal Attachment Program Advisory Committee (TAPAC) and the Radio Advisory Board of Canada (RABC), which are government/industry consultative committees on telecommunications and radiocommunication matters. All feedback from the committees on the proposal was positive. Members of the committees indicated that the new fees should be established as early as possible, as industry is eagerly awaiting the implementation of this new fee structure.

An official consultation on a new fee structure for telecommunications and radio apparatus-related services was launched on March 6, 2004 (*Canada Gazette* notice No. SMSE-006-04), and closed on May 20, 2004. The *Canada Gazette* notice invited the public, including interested parties, to provide comments on the new fee structure. No negative comments were received.

In accordance with the *User Fees Act*, the registration and listing fees were presented to both Houses of Parliament and were approved in the fall of 2006.

#### Fee schedule

The Minister of Industry, pursuant to sections 18 and 20 of the *Department of Industry Act*, hereby fixes the following fees, effective September 10, 2007. The fees are applicable to the assessment, registration, listing and to the provision of technical expertise services provided by the Minister pursuant to the *Radiocommunication Act* and the *Telecommunications Act* to regulate radio and telecommunications apparatus for compliance with technical standards established by the Minister under these Acts.

# Interpretation

For the purpose of this fee schedule,

"apparatus" means telecommunications or radio apparatus;

"Bureau" refers to the Certification and Engineering Bureau of the Department of Industry;

"certification" refers to a procedure whereby the Department of Industry or a third party gives written assurance that a product, process or service conforms to specified requirements;

"Conformity Assessment Body" means a body engaged in any activity concerned with determining directly or indirectly that the relevant requirements are fulfilled;

"Department" means the Department of Industry;

"engineering brief" means a written submission, signed by a responsible person, containing significant technical information or design data and description of the tests that have been conducted, including the results of such tests, for the purpose of confirming that the apparatus complies with the applicable technical requirements, specifications, or standards:

"Minister" means the Minister of Industry; and

"technical requirements, specifications or standards" means, in respect of each application for the assessment of apparatus, only such technical requirements, specifications or standards as apply to that apparatus.

# Assessment fee

Where a person applies to the Minister for the assessment of apparatus for the purpose of determining compliance with technical requirements, specifications and standards, and for issuing a Technical Acceptance Certificate, as applicable, that person shall pay an assessment fee of \$1.200.

Technical expertise fee

Where a person applies to the Minister for technical support or the testing of apparatus by

the Bureau for the purpose of determining compliance with technical requirements, specifications or standards, as well as for reassessment and assistance in the evaluation of the technical competence of conformity assessment bodies, that person shall pay a technical expertise fee calculated at the rate of \$150 per hour or part thereof. In the case of a reassessment, the total charges shall not exceed the assessment fee of \$1,200.

# Registration fee

Where a person applies to the Minister for the registration of apparatus in a list maintained and published by the Minister for the purpose of informing the public of telecommunications apparatus that comply with technical requirements, specifications and standards established by the Minister, that person shall pay \$750 per submission in addition to any other applicable fee.

# Listing fee

Where a person applies to the Minister to list apparatus subject to certification in a list maintained and published by the Minister for the purpose of informing the public of radio apparatus that comply with technical requirements, specifications and standards established by the Minister, that person shall pay \$50 per product listed in addition to any other applicable fee.

# Payment of fees

The fees outlined in this Order are payable at the time of making the application, except for the technical expertise fee which will be payable before services are rendered.
