TitleDraft Commission Directive amending, for the purpose of its adaptation to technical progress, for the 31st time, Council Directive 67/548/EEC on the approximation of the laws, regulations and administrative provisions relating to the classification, packaging and labelling of dangerous substances. (Directive: 2 pages; Annexes: 30 pages; Explanatory note: 7 pages, in English).

Description of contentThis draft Commission Directive, amending Directive 67/548/EEC, introduces and modifies the EU harmonised classification and labelling requirements for about 600 substances, removes the requirements for 4 substances. The inclusion of the entries for Nickel compounds is still under internal review. If the draft Directive is modified in this respect, the European Communities will submit a revised draft Directive and a revised explanatory note, if possible within the 60 days commenting period.
