Introduction to the Israeli Standard

This Israel Standard is the Standard of the European Organization for Standardization EN 471 of September 2003 approved in the English language as an Israel Standard with modifications and additions.

Abstract of the scope

This Standard specifies requirements for protective clothing capable of signalling the user's presence visually, intended to provide conspicuity of the user in hazardous situations under any light conditions by day and under illumination by vehicle headlights in the dark.
