

Summary of the revision of J55001 “Standard for Noise Intensity” in the Technical Requirements Recognized by the Ministry of Economy, Trade and Industry in Accordance with Section 2 of the Ordinance

J55001 is a technical requirement in the ministerial ordinance, “Technical Requirements Recognized by the Ministry of Economy, Trade and Industry in Accordance with Section 2 of the Ordinance” based on the Electrical Appliance and Material Safety Law.

The scope of application of J55001 “Standard for Noise Intensity” will be revised by adopting J55015 “Limits and Methods of Measurement of Radio Disturbance Characteristics of Electrical Lighting and Similar Equipment” that is based on a CISPR international standard. Furthermore, J55014-1 “Electromagnetic Compatibility - Requirements for Household Appliances, Electric Tools and Similar Apparatus” and J55022 “Information Technology Equipment - Radio Disturbance Characteristics - Limits and Methods of Measurement” will be aligned with CISPR international standards.
