## MEAT MEAL FOR COMPOUNDING AIMAL FEEDS- SPECIFICATION

## 1. SCOPE

This standard prescribes minimum requirements for meat meal used in compounding animal feeds.

## 2. **DEFINITION**

Meat meal shall be the rendered product from mammal tissues, excluding bones, blood, hair, hoof, horn, hide trimmings, manure and stomach contents except in such amounts as may occur unavoidably in good processing practices.

### **3. REQUIREMENTS**

- **3.1** Meat meal shall be free from rancidity, toxic ingredients, adulterants, foreign matter, insects and pathogenic micro-organisms.
- **3.2** It shall be in the form of a powder.
- **3.3** It shall have a characteristic cooked meat smell.
- **3.4** It shall conform to the requirements in Table 1 below:

Acid insoluble ash, (max.)	1.0	
Nacl, (max.)	4

NOTES: 1. The values of specified calcium and phosphorus are on a moisture free basis.

2. The calcium level shall be not more than 2.2 times the phosphorus level.

4.1 Meat meal shall be free from *salmonellae*, spores of *bacillus anthracis* and clostridia when tested according to the method prescribed in KS 01-63: Part  $3^*$ 

4.2. Meat meal shall be adequately treated with an antioxidant.

## 5. PACKAGING AND LABELLING

## 5.1 Packaging

- **5.1.1** Compounded meat meal for sale shall be packed in containers which are of sufficient strength and sufficiently sealed so as to withstand reasonable handling without tearing, bursting or falling open during normal handling and transportation.
- **5.1.2** Each container for Compounded meat meal shall be clean and free from visible indications of contamination, infection and insect infestation.
- **5.2 Labelling** the packages shall be securely closed and marked with the following information:
  - (i) Name of product; 'Meat Meal';
  - (ii) Net Weight of the product;
  - (iii) Batch number;
  - (iv) Name and physical address of the manufacturer;
  - (v) Date of manufacture and expiry
  - (vi) Crude protein, calcium, phosphorus and fat contents;
  - (Vii). Instructions for use and storage
