**COMMUNIQUÉ ON
TS ISO 9981 BELT DRIVE – PULLEYS AND V BELTS FOR AUTOMOTIVE
INDUSTRIES – PK PROFILE: DIMENSIONS FOR THE ASSEMBLIES STANDARD
(COMMUNIQUÉ NO: MSG – MS – 2018 /)**

Purpose

ARTICLE 1 – (1) The purpose of this Communiqué is to identify issues related to the implementation of application of TS ISO 9981 (August 2015) “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions” standard.

Scope

ARTICLE 2 – (1) This standard covers the main dimensional characteristics of combed V pulley groove profiles used with PK profiled, combed, endless V belts for automotive auxiliary drive applications.

(2) The arrangement of combed V belts and pulleys on PH, PJ, PK, PL and PM profiles for industrial and non-automotive applications is the subject of the ISO 9982 “Belt Drive – Pulleys and V-Belts for Industrial Applications – PH, PJ, PK, PL and PM Profiles: Dimensions” Standard. The dimensions and tolerances of the PK belt profile are the same in both International Standards.

Legal Basis

ARTICLE 3 – (1) This Communiqué; has been drawn up based on the Presidential Decree Law No 1 on Organization of the Presidency published in the Official Journal numbered 30474 and dated 10/7/2018, Law No. 1705 on the Prevention of Adulteration in Trade and Supervision and Protection of Exports dated 10/6/1930, Presidential Decree No 4 on the Organization of Affiliated, Related, Associated Institutions and Institutions and Other Institutions and Organizations which are affiliated to Ministries published in the Official Journal numbered 30479 and dated 10/7/2018 and Regulation on Mutual Recognition in Non-regulated Areas that was put into force with the Decision No. 2012/3169 of the Council of Ministers dated 2/5/2012.

Putting into Effect

ARTICLE 4 – (1) TS 148 “For Pulleys-For Belts” (December 1998) standard is canceled. Instead, TS ISO 254 “Drive Belt – Belt Pulleys - Quality, Surface Condition and Balance”, TS ISO 5290 “Belt Drive – Grooved Pulleys for Narrow V-Belts - Groove Profile 9N / J, 15N / J and 25N / J (effective system)”, TS ISO 5291 “Belt Drive – Grooved Pulleys for Classical Combined V-Belts - Groove Profile AJ, BJ, CJ and DJ (effective system)”, TS ISO 9980 “Belt Drive – Grooved Pulleys for V-Belts (System based on effective width) - Geometrical Inspection Of Grooves”, TS ISO 9981 “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions”, TS ISO 9982 “Belt Drive – Pulleys and V-Belts for Industrial Applications – PH, PJ, PK, PL and PM Profiles: Dimensions” standards was decided to be published in the meeting of Technical Board of Turkish Standards Institution (TSE) dated 09/01/2017 has been put into effect as mandatory in manufacturing and sales stages.

Compliance Obligation

ARTICLE 5– (1) Those who produce and sell products on the market within the scope of TS ISO TS ISO 9981 (August 2015) “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions” Standard shall be obliged to comply with the provisions of this Communiqué.

Mutual Recognition Clause

ARTICLE 6 – (1) The provisions of this Communiqué on TS ISO 9981 (August 2015) “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions” shall not apply to the products which were legally produced or put into free circulation in a Member State of the European Union.

(2) Nonetheless, the Ministry of Industry and Technology may submit the product referred to in paragraph (1) to an evaluation following the rules and procedures laid down in Chapter Three of Regulation on Mutual Recognition in Non-Harmonised Area which was put into force by Decision of Council of Ministers No. 2012/3169 of 2/5/2012 and as a result of this evaluation if it finds out that this product does not provide a level of protection equivalent to that sought by this Communiqué on TS ISO 9981 (August 2015) “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions” it may prohibit placing on the market of the product, make its placing on the market subject to prior conditions or have the product withdrawn or recalled from the market.

Provision

ARTICLE 7 – (1) TS ISO 9981 (August 2015) “Belt Drive – Pulleys and V-Belts for Automotive Industries – PK Profile: Dimensions” Standard shall be obtained from the central organization or provincial representative offices of TSE. Contact information can be accessed from the website of the TSE.

Repeal

ARTICLE 8 – (1) TS 148 “For Pulleys-For Belts” (December 1998) standard which was put into effect as mandatory with the Mandatory Standard Communiqué (Communiqué No: Mandatory Standard- MS.98/110-111) that was published in the Official Gazette No: 23568 and dated 29/12/1998 has been repealed.

Entry into Force

ARTICLE 9 – (1) This Communiqué shall enter into force six months after its publication.

Enforcement

ARTICLE 10 – (1) The provisions of this Communiqué shall be enforced by the Minister of Industry and Technology.
